Almaden Hills Trail Run

Saturday, August 25, 2018

Time: 8:00 am – 50k, Trail Marathon, 13.1 mile, 8.6 mile, 10k, 5k, 1.5 mile, and .5 mile

Location: Almaden Quicksilver Park

Course: 60% dirt roads, 40% single track, very hilly, awesome country, challenging and very fun

Aid: 4 fully stocked aid stations

Directions: Almaden Quicksilver Country Park: The Mockingbird Lane entrance is accessed off Mockingbird Hill Lane. This entrance is accessible to all users, including bicyclists. From Highway 85, take Almaden Expressway exit south 4.5 miles to (right on) Almaden Road. Proceed 0.5 miles on Almaden Road to Mockingbird Hill Lane, turn right and continue 0.4 miles to the parking area. Almaden Quicksilver Park is located in south San Jose, in the town of New Almaden. *You can reach the park office at 408-268-3883.*

Entry Fee: \$90/50K \$80/26.2 mi \$50/13.1 mi \$45/8 mi \$40/10k \$35/5k \$25/1.5 mile \$20/.5 mile
