Location: Calero Park Run

Course: 50/50 dirt roads, awesome single track, very hilly, challenging, great trainer for Western States, oak trees, exposure, good heat training, enjoy panoramic vistas.

Aid: 4 fully stocked aid stations

Directions: The park is located off McKean Road. Traveling to the park, from central San Jose, take Almaden Expressway south. Turn right onto Harry Road, then left onto McKean Road. The park is 3.5 miles south of Harry Road on the right past Calero reservoir. Traveling to the park from 101, exit Bailey Avenue and head west until you reach McKean Road. Turn left onto McKean Road. Calero Park entrance is on the right side 0.5 mile.

Parking: Park at Calero Parking Lot off McKean Road

Entry Fee: **\$40/5k \$45/10k \$50/15k \$55/13.1 mi \$60/25k \$80/50k**
