Start Time: 9:00 am – 5K, 10K, 15K, Half Marathon

Location: Marshall Gold Discovery State Historic Park, Coloma, CA

Course: This event is run entirely inside the Marshall Gold Discovery State Historic Park, set in the beautiful foothills of Coloma along the south fork of the American River.

Aid: 3 fully stocked aid stations.

Directions: Marshall Gold Discovery State Historic Park is located on Highway 49 in Coloma, between Auburn and Placerville. Please park in the North Beach parking lot located at the north end of the park. Note there is an \$8.00 parking fee per vehicle. Golden Poppy passes are accepted.

Entry Fees: \$45/5K, \$50/10K, \$55/15K, \$60/Half Marathon

Entry fees are non-refundable unless event is canceled. Pre-registered runners qualify to purchase a T-shirt for an additional \$25 if they register at least 12 days (two Mondays) before the Saturday events. Mailed applications must be received by the Wednesday before the event. Active Military receive a 15% discount with no penalty for race day registration.
