Aid Stations: Two fully stocked aid stations.

Directions: From Hwy 50 exit at El Dorado Hills Blvd: go underneath the Hwy drive on El Dorado Hills Blvd for 4 miles. At the Green Valley traffic light cross over Green Valley road onto Salmon Falls road. Drive on Salmon Falls road for 2.9 miles. Falcon Crest parking lot will be on your left.
NO parking fee is required. Carpooling is encouraged.

Drop Bags: Leave the at the Start/Finish. Delivered the Fitch Way aid station turnaround.

Entry Fee: \$60/Half Marathon \$50/8 miles \$45/10k \$40/5k
